



- 1. The Owners column has been modified from the original data from LINZ.
- a. The Department of Conservation (DOC) has been listed as the owner in cases where 1) there was no owner information available in the LINZ data and 2) the majority of a parcel fell within the DOC Public Conservation Area dataset. Note, this land is managed, but not necessarily owned, by DOC. DOC Public Conservation Areas that only cover a portion of a parcel can be seen graphically on the map but are not reflected in the table.
- b. The Crown has been listed as the owner in cases where 1) there was no owner information available in the LINZ data and 2) the parcel statutory reference indicated Crown ownership (or vesting).
- c. Owner names have been modified where inconsistencies in spelling and text entry were noted. E.g. The New Plymouth District Council and New Plymouth District Council.
- 2. Owner Type is listed as Iwi based on data from the Maori Land Online web application (https://www.maorilandonline.govt.nz/) or where the parcel intent is Maori. This may not be reflective of all Maori owned land or interests in the area.
