I am writing in support of the application for consent renewals for the Opunake Power Scheme.

The Opunake Power Station is part of the history of the region , and South Taranaki District Council has been spending considerable effort in canvassing ratepayers on the "Good Bad and Ugly " of the region . This is an asset of good which needs to be preserved ,and operated for the good of all. Engineering feats which created this transformation from Market garden to lake/ power station are part of a country's history which should not be forgotten.

The tail race has existed as part of Opunake Beach culture and awareness , with the siren sounding when discharge is about to

This is a favorite fishing spot for my family, and often joined by others, adjoining the tail race, as the Kahawai enjoyed this outlet when the power station was operational. During white bait season people sat upon the outlet netting for their special catch.
