The Urenui & Districts Health Group Committee are concerned about the renewal of the resource consent from a community health viewpoint; please consider the following points:

Air emissions - Discharge from the site results in an objectionable odour and dust. This not only effects neighboring properties but is also smelt strongly when driving past 1460 Mokau Road. From a health point of view this is extremely concerning because we have no way of knowing the health issues that may arise from inhalation, dust residue on the skin and ingesting the dust particles. A large percentage of the neighboring properties have residents with compromised immune systems and health conditions, we believe those residents are entitled to breath clean air and not have contaminants come on to their properties.

Transfer of contaminants - Hundreds of seagulls also can be seen going into the Remediation site everyday, what contaminants are eaten by those birds then released in other areas though the birds faeces - we are concerned that contaminants are easily spread this way and will affect our wildlife and human health.

The discharge of waste material, treated stormwater &

leachate - Community members visiting the river have complained about hydro carbon smells and irritated skin, It is reasonably well known that the fish life is not at the same numbers they once were in the Mimi river, which the Haehanga stream feeds in to - has Remediation NZ been compliant with its current consent? and if not has discharging leachate contributed to lowering fish numbers, the odour present on some days at the river and the irritated skin complaints - once again the health impact is not known for those who are breathing in the air, swimming in and eating from the river.

Uruti is known to have a high rainfall/regular surface flooding and with that will contribute to contaminants being carried easily down the river, would it not have been a better idea to put a facility like this in a less flood prone area?
