## TERMS AND CONDITIONS

All references to "TRC", "we", "us" or "our" in this application form shall refer to Taranaki Regional Council, being a local authority established under the Local Government Act 2002. All references to "you" or "your" shall mean the donor specified on this application form.

References to the following terms shall bear the corresponding meanings: "Brochure" shall mean our *Support Pukeiti* brochure. "Project" shall mean your project of choice from the selection set out in the brochure and identified above (if any); "Donation" means the donation amount specified on this application form, and if towards a specified project, shall be the corresponding amount prescribed in the brochure.

The following terms and conditions apply to all donations:

1. *Support Pukeiti* (and all projects carried out thereunder) will create benefits generally available to the public and will not in any circumstances be for the exclusive benefit of any donor or donors.
2. Donations are not subject to GST. You will not be provided with a tax invoice for donations made.
3. We reserve all rights in relation to each project and no donation shall provide any donor with rights in relation to any project. TRC's rights in relation to each project shall include without limitation the following rights:
  - 3.1 to finalise all design and technical aspects for each project; and
  - 3.2 to choose the final location for each project; notwithstanding any specific details requested by a donor.
4. Donations are paid to us on a full and final basis and are entirely non-refundable and whether or not any project is completed to the satisfaction of any donor.
5. Except where a donation is made for a specified project, we reserve the right to apply donations towards any purpose associated with Pukeiti or with *Support Pukeiti*.
6. The collection and use of personal information by TRC is regulated by the Privacy Act 2020.
7. The benefactor register will remain indefinitely available to the public, subject always to TRC's discretion.
8. TRC will not be responsible for any failure to contact you for any reason if your contact details have changed and you have failed to provide your updated contact details.

The following terms and conditions apply to seats only:

9. We will use all reasonable endeavors to ensure that seats (and any associated plaques) are maintained and remain in the agreed location for a period of ten years.
10. Subject to clause 9 above, seats (and any associated plaques) will be removed from Pukeiti at our discretion.
11. By selecting the option in the application form for TRC to contact you when the seat has been in situ for ten years, you are consenting to us retaining your contact details for this duration and purpose.
12. When the seat is removed from Pukeiti, TRC will retain the plaque in storage and donors are entitled to retrieve the plaque on request.
13. Our prior written consent is required to scatter ashes at Pukeiti. With our consent you will be permitted to spread ashes in a designated area of the garden (along the Ireland Walk). Note that this area is not located near any available seat locations.
