*I believe it is inadvisable for the Taranaki Regional Council to establish a Maori Ward as it will be based on race and restrict Maori, that are on the Maori Electoral Roll, to only vote for one candidate, where-as, they can vote for multiple candidates now, dependant on which ward they are in today.*

*Presently there are only 52% of Maori registered on the Maori Electoral Roll, and at the last opportunity to register, in 2018, the number registered dropped. Maori are divided on the best pathway forward, and I believe the majority favour integration, rather than separation or segregation.*

*There has been much done to redress past wrongs, and the benefits to Maori are enormous, and are continually growing.*

*The proposed change restricts the influence of of Maori voters, to electing only one candidate, and rather than increases, polarises the influence of Maori.*

*Already you have consultations on issues with representative Maori groups, as you do with other affected parties, and I believe it is wrong to have an electoral system based on race, any race. Maori have the same rights as all New Zealanders, and I do not favour an apartheid electoral process being adopted by the TRC.*

*Another consideration is that at this time in Local Government Elected Representatives, the percentage of Maori Councillors exactly represents the percentage of Maori in New Zealand. Equitable. That is that 13% of New Zealanders are Maori, and 13% of elected Local Government Councillors are Maori. Where is the problem. There is not an issue of under representation of Maori in Local Government.*

*Maori are an important part of New Zealand's society, but not deserving of privilege and or status above that accorded any other race in New Zealand in this, the 21<sup>st</sup> century.*

*There for, I believe that the proposed establishment of Maori Wards for the election of Councillors to the Taranaki Regional Council is a polarising step, that will create division and disharmony, because it will be seen as, at best an unjustified privilege, and at worst undemocratic.*


