REGIONAL WASTE MINIMISATION OFFICER'S ACTIVITY REPORT (MAY 2024 – JULY 2024)

PURPOSE/ TE WHĀINGA

1. The purpose of this report is to provide an update on waste minimisation activities undertaken by the Council officers of New Plymouth District Council (NPDC), South Taranaki District Council (STDC) and Stratford District Council (SDC).

RECOMMENDATION / NGĀ WHAIKUPU

That the Taranaki Solid Waste Management Committee:

Receives the report and notes the activities reported by the Regional Waste Minimisation Officer and District Councils.

SIGNIFICANCE AND ENGAGEMENT / TOHUTOHU KAI WHAKAHAERE

2. This report is provided for information purposes only, and has been assessed as being of some importance.

BACKGROUND / WHAKAPAPA

3. Waste Management and Minimisation Plans (WMMP) are the guiding document for directing waste management and minimisation actions across territorial authorities and is required to be reviewed every six years. WMMPs include action plans for delivering on the outcomes of the Plan. The WMMP for each Taranaki territorial authority was adopted on:

NPDC	31 October 2023
SDC	14 November 2023
STDC	17 November 2023

4. An activity report is a standard item presented to the Taranaki Solid Waste Management Committee (referred to as Committee) and provides information of recent and upcoming activities, which helps inform the Committee on how the Taranaki Territorial Authorities are tracking on the delivery on of the WMMPs outcomes.

DISCUSSION/ KŌRERORERO

5. Activities that have delivered on the WMMP are summarised for the Committee's information:

NPDC Zero Waste Fund – latest funding round

6. NPDC runs a twice yearly Zero Waste Fund for initiatives that will minimise waste. The second round was open for applications from 15th April – 10th May 2024.
7. The Fund received 11 applications. Two of the submitted applications were successful. A total of \$12,600 was allocated for the two successful projects from this round. Three applications were noted for further collaboration and support for subsequent funding rounds.
8. The successful applicants were Stitch up Society who will be holding workshops on textile upcycling and repair and Te Rau o Rongo Charitable Trust- He Mahi Pū Waitākau who will be holding composting workshops for Māori whanau.
9. The textile repair workshops link to the action from the NPDC WMMP of expanding and promoting Zero Waste grants to support initiatives that promote reuse and repair.
10. The composting workshops contribute to the actions of establishing a community-based composting network and expanding behaviour change programmes to support composting, reducing food waste and food rescue.

NPDC Zero Waste Fund – active projects

11. A successful application for the previous round of zero waste fund, was the Rautāpatu Foundation. They are holding a three-day Circular Economy conference from the 14th – 16th August 2024. The conference contributes to the action 'Expand and promote zero waste fund grants to support initiatives that promote circular economy in different communities including iwi, hapū, marae and whanau' from the NPDC WMMP.
12. As part of the March 2023 Zero Waste Fund round, NPDC helped fund the construction of the Wash over Waste trailer. The trailer is a portable dishwashing station which is to be used at the Seaside Markets by Ngamotu beach. The trailer launched at the Seaside Market on 7 July, and vendors are now required to use reusable crockery when serving food, reducing the overall amount of waste generated at the event.



Zero Waste Events

13. Under the NPDC Solid Waste Management and Minimisation Bylaw of 2019, a Waste Management and Minimisation Plan is required for any event that receives Council funding or support and/or is held on Council land. Through this Bylaw, Council officers have supported event organisers by assisting with their waste plans, providing volunteer support for managing waste and subsidizing bin costs if the event reaches a 50 per cent diversion from landfill rate.
14. Below is a summary of the zero waste events data between 1 May - 30 June 2024.

WasteMINZ 2024 Conference

- NPDC Council officers showcased two presentations at this year's national WasteMINZ conference. One presentation focused on the Circular Stationery programme pilot project. The other presentation focused on the collaborative approach undertaken for the development of the NPDC Waste Management and Minimisation Plan. The Taranaki Regional Waste Minimisation Officer was also a panellist for the Young Talent Time panel discussion which discussed the benefits and tips for attracting young people to the waste sector.



Construction and Demolition Waste - Tradie Breakfast

- NPDC are co-hosting a Tradie Breakfast with support from Mitre 10 and 3R on 26 July at Mitre 10 Mega, New Plymouth. The free event is designed to support those working in construction and demolition industries across the region and help them to better understand options for waste reduction on site and diversion of materials from landfill. The session will discuss how the Council works with local industry to reduce waste to landfill including construction waste plans and the Sorting Depot.

17. The event links to several actions in the Commercial waste section of the NPDC WMMP action plan, particularly to the actions of expanding behaviour change programmes to support the commercial sector to transition to a circular economy and connecting construction organisations with material re-users and consumers.

STDC Resource Wise Business Programme

18. STDC has begun implementing the Resource Wise Business programme, starting with Council facilities. The programme starts with conducting a waste audit to collect baseline data, introducing interventions to reduce waste, and monitoring changes in waste volumes and diversion rates.
19. The four Council buildings that have been audited to date are:
- The Administration Building
 - Te W'anake The Foundry
 - The pound
 - The iSite
20. Data on waste generation, diversion, and potential for increased recycling was collected and analysed following the audits. Baseline diversion rates across the four locations showed significant variation, ranging from 79 per cent to 9 per cent.
21. To improve diversion rates, the following initiatives have been introduced across the council buildings:
- a) Staff Education and Awareness: Initiatives to educate staff on waste management practices and the importance of reducing landfill waste.
 - b) Keep Cup Libraries: Establishing libraries for reusable cups to minimise disposable cup usage.
 - c) Organics Collection: Introducing or enhancing the collection of organic waste to ensure it is composted rather than sent to landfill.
 - d) Mixed Recycling Collection: Improving the collection and sorting of mixed recyclables to increase recycling rates.
 - e) Clearer Signage: Installing better signage to guide proper waste disposal and recycling efforts.
22. Waste audits will be conducted at the remaining council facilities over the coming months.

CLIMATE CHANGE IMPACT AND CONSIDERATIONS / HURINGA ĀHUARANGI

23. Emissions generated from waste are one of the key emission reduction sources identified nationally. The region's work to reduce waste and focus on circular economy will result in reducing emissions from waste. All Waste Management and Minimisation Plans in the region include emission reduction targets.

REFORM IMPLICATIONS

24. The Future for Local Government Review highlighted the shared service opportunities across local government. Waste and resource recovery activities within Taranaki already have a high degree of sharing resources, approaches, services and infrastructure.

NEXT STEPS / HĪKOI I MURI MAI

25. The Waste Management and Minimisation Plan determines all waste minimisation activities from 2023- 2029. The report will continue to provide updates to the committee on progress towards the actions in the plan.

REGIONAL SOLID WASTE OPERATIONS REPORT (MAY 2024 - JULY 2024)

PURPOSE/ TE WHĀINGA

1. The purpose of this report is to update on the regional waste services undertaken by New Plymouth District Council (NPDC), South Taranaki District Council (STDC), and Stratford District Council (SDC).

RECOMMENDATION / NGĀ WHAIKUPU

That, having considered all matters raised in the report, the report be noted.

SIGNIFICANCE AND ENGAGEMENT / TOHUTOHU KAI WHAKAHAERE

2. This report is provided for information purposes only, and has been assessed as being of some importance.

BACKGROUND / WHAKAPAPA

3. NPDC, STDC, and SDC have a regional joint services contract for solid waste kerbside collection and transfer station operations. The scope of works includes Landfill, Recycling, Glass and Organics Collections; full management and operation of all Refuse Transfer Stations; provision of bins and bulk haulage from the Refuse Transfer Stations for all waste streams and processing of organics for a temporary period.
4. The current solid waste contract ends on 30 September 2024. A new contract has been awarded and the service will begin on 1 October 2024.
5. In addition, local waste services include The Sorting Depot Commercial Materials Processing Facility (NPDC); Colson Rd Landfill Closure (NPDC); The Junction (NPDC); Rural Transfer Stations.
6. Colson Road Landfill continues with final capping of the Northern most part and is currently programmed to be completed in the construction season of Oct 24 – May 25.

DISCUSSION

Solid Waste Services provider changing

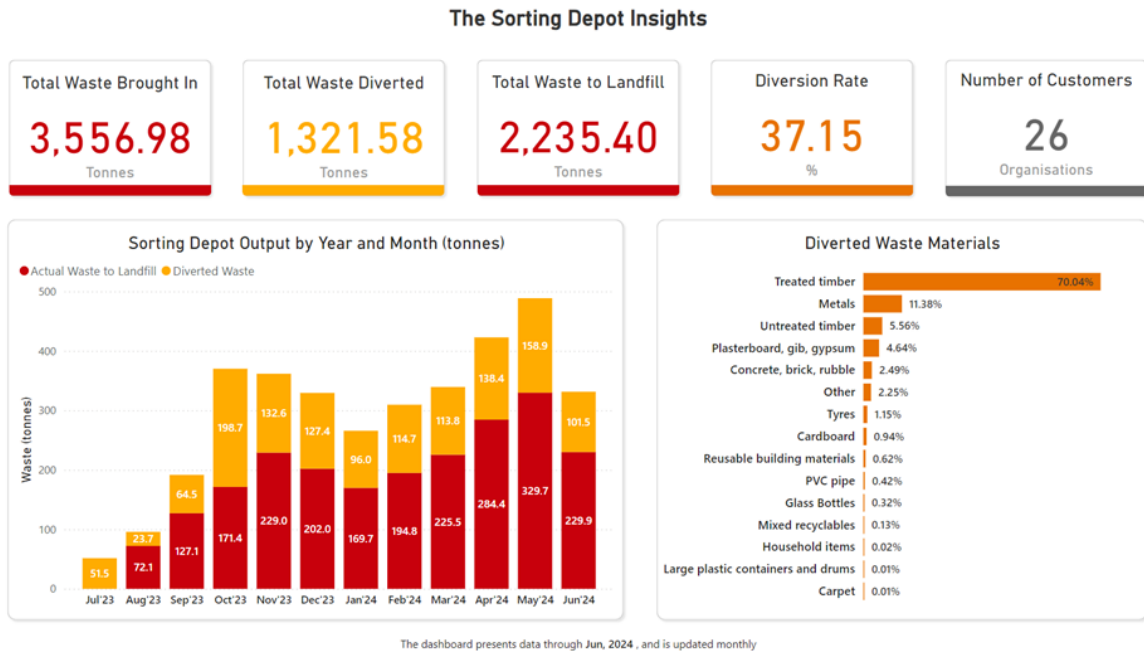
7. EnviroNZ are the current contractor for the Taranaki's solid waste services which include kerbside collections and transfer station operations. The current contract ends on 30 September 2024.
-

8. Waste Management NZ will be commencing services from 1 October 2024.
9. STDC will be implementing a range of service-level changes as part of this new contract including a food scraps collection, change in collection days and frequencies, and transfer station opening hours.
10. Properties located within the collection area for STDC will receive a new set of bins, including a food scraps bin for the new service.
11. South Taranaki's communication planning is underway and educational materials will accompany the bin roll out. Some residents will be changing collection days.
12. An open day with Waste Management is planned for South Taranaki leading up to the kerbside changes to help residents understand the changes to the kerbside service.
13. Waste Management will be upgrading the kiosks located at the refuse transfer stations by providing a roof run-off tank for rainwater and a solar panel for electricity for the sites.
14. The transfer station operation hours will be changing for Ōpunakē, Waverley, and Waitōtara from 1 October 2024. This is to allow for efficient resourcing and provide one operator for Manaia and Ōpunakē and one for Waverley and Waitōtara, reducing the staff requirements from four to two.

The Sorting Depot commercial waste processing facility

15. The Sorting Depot on Colson Road, New Plymouth opened in July 2023. The facility is open to account customers and accepts skip bins of commercial and demolition waste for sorting.
 16. Figure 1 shows the data breakdown of diversion and tonnes to landfill from July 2023 – June 2024.
 17. The total tonnes entering the Sorting Depot has steadily increased from January 2024 to May 2024, however a decline is noted in June 2024. The facility is averaging a 37.15% diversion rate and has 26 registered customers.
 18. The decline in tonnes entering the Sorting Depot was due to construction activities decreasing during winter periods.
 19. Waste Management incoming tonnes has increased over the past quarter.
 20. End markets continue to be sourced to ensure products are reused, recycled. Polystyrene will be on the future end market to secure.
-

21. Material continues to be diverted from The Sorting Depot to The Junction and then onsold. 23/24 final figures to be provided with next quarterly report.



The Junction

22. Since opening, The Junction has achieved:

- 698 tonnes of waste diverted from landfill;
- 20 jobs created;
- 119,304 visitors and drop-offs;
- 235,351 items sold;
- Continuing to build new business & community relationships.

23. Awaiting approval of lodged consents for the new building at The Junction – this will create new opportunities for WISE to continue to develop the site to become 100% sustainable and provide educational programmes for the public.

Pātea Beach Sand Dune Management Plan

24. STDC staff have been working with the Coastal Scientist and Ngāti Ruanui to apply for a renewal of the Pātea Beach Greenwaste Discharge Resource Consent.
25. As part of this application, a Sand Dune Management Plan is required Iwi have reviewed the plan and requested some clarification and amendments. STDC

has replied and are waiting for the final review by Iwi. Some of the urgent actions in the plan have been actioned.

26. A sign has been erected at the top car park and a barrier placed across the path to close the old beach access which has become dangerous due to unstable sand dunes and some suitable greenwaste has been placed on the blowouts in the dunes to prevent further erosion.

27. Waste emissions are one of the key emission reduction sources identified nationally. The region's work to reduce waste to landfill and recover organic materials will result in reducing emissions from waste.

REFORM IMPLICATIONS

28. The Future for Local Government Review highlighted the shared service opportunities across local government. Waste and resource recovery activities within Taranaki already have a high degree of sharing resources, approaches, services and infrastructure.

NEXT STEPS / HĪKOI I MURI MAI

29. The Solid Waste Services contract is a ten-year contract between Waste Management NZ and the Taranaki district councils. Contractor KPI's will continue to be monitored and reported to the committee.
30. Promote Sorting Depot within NPDC departments to capture new builds via consenting process and other opportunities.

31. Review the original Sorting Depot business case and recalibrate it against Year 1 actuals.

Purpose

1. The purpose of this memorandum is to provide an update to the Committee of the plan for a tour of recycling and waste sorting facilities following the meeting on Thursday 14 November 2024.

Recommendations

That Taranaki Regional Council:

Background

2. In previous years the Taranaki Solid Waste Committee has visited and held meetings at various waste facilities throughout Taranaki. This has not been undertaken in recent years and the Committee has suggested that a tour be planned for this year.

Discussion

3. The aim of the tour is to provide an opportunity for the Committee to see, in practice, a range of activities reported to them, including some of the practical challenges and opportunities associated with Solid Waste management. This will help inform discussion around progress with waste management and minimisation initiatives, as well as future opportunities.
