## Proposed Coastal Plan for Taranaki

Pursuant to Clause 5 of the First Schedule of the Resource Management Act 1991, the Taranaki Regional Council gives notice that it has prepared a Proposed Coastal Plan for Taranaki and that it is open for submissions.

The Proposed Coastal Plan for Taranaki assists the Council in carrying out its functions to promote the sustainable management of coastal resources in Taranaki. Please note as per Part 86B(3) of the Resource Management Act 1991 the plan rules will have immediate legal effect.

The Taranaki Regional Council now invites written submissions on the Proposed Coastal Plan for Taranaki. These can be made by any person and can be submitted by:

- Emailing Taranaki Regional Council at [coastal@trc.govt.nz](mailto:coastal@trc.govt.nz) and including as the subject 'Submission on the Proposed Coastal Plan for Taranaki'
- Posting your submission to Taranaki Regional Council, Private Bag 713, Stratford 4352 and including as the subject 'Submission on the Proposed Coastal Plan for Taranaki'.

**The closing date for written submissions is 4.00pm Friday 27 April 2018.**

Submissions should state:

- Full name, email address, postal address and telephone number of the person making the submission;
- The date of the submission;
- The specific provisions of the Proposed Coastal Plan for Taranaki to which the submission relates;
- The nature of the submission (in summary); whether you support or oppose the specific provisions or wish to have amendments made, giving reasons;
- The precise details of the decision you wish the Taranaki Regional Council to make;
- Whether or not you wish to be heard in support of your submission; and
- The signature of the person making the submission (or the person authorised to sign on their behalf).

Following the receipt of written submissions the Taranaki Regional Council shall:

- Publicly notify the availability of a summary of all decisions requested by those who made a submission, where the summary of decisions and the submissions can be inspected, and call for further submissions in support of or in opposition to the initial submissions;
- Where necessary or appropriate or where requested, convene meetings with any person who made a submission, to potentially resolve matters raised in submissions; and
- Hold a hearing into remaining submissions.
